Foreword common to Deliverables D5 to D8

Setting up the Strategic Advisory Board (StratAB) required a general and homogeneous internal awareness of the objectives and structure of EUt+, both as a project and as an initiative, so as to bring the debate from internal players to the external parties that compose the StratAB. As indicated in previous deliverables, this awareness was built up gradually, but through internal tensions which led (1) to the destabilization of the governing board as initially planned and (2) to the creation of Rectors Board, Student Board and sectoral committees (education, research, then IT). These bodies brought together top-level representatives from each sector. Before they could consider EUt+ collectively, it became clear that they needed to get to know each other and integrate EUt+ issues into each of their sectors. These meetings were structured progressively: a constitutive text is not enough to create a functional body, and a gradual awareness was needed, enabling a generally nonlinear trajectory of appropriation. Significant time was needed to reach an effective operation of these bodies.

The absence of a truly functional Governing Board meant that clear problematics could not be brought to the attention of an external body such as StratAB. Moreover, initial contacts with potential StratAB members showed that they were particularly interested and curious about the question, but expected more information than they were able to give a critical view of our approach.

StratAB meetings could theoretically have been held, but their contribution would not have fulfilled expectations. As initial appropriation required more internal work than external advice, our resources (and strengths) were focused on setting up and supporting the bodies mentioned above.

TOPIC 1 OPENING AND AGENDA

TOPIC 3 ANALYSIS OF RESEARCH COLLABORATIONS IN EUt+

In the scope of the EXTRAS project task X4.1 focused on the performance of an EUt+ internal analysis of research collaborations among the EUt+ partners and with the local ecosystems. This analysis was performed with external consultancy support by SIRIS and resulted in a toolkit called EUt+ R&I mapping. This consists of three toolkit products. The Interactive Platform is a tool aimed at presenting and facilitating interactive exploration of research and innovation capacities of the EUt+ member universities. Through topic modeling, it groups together documents about similar thematics, allowing to see overlaps in research and innovation between the partners, and thus paving the way for further collaboration. The EUt+ R&I mapping slide deck provides an in-depth analysis of the research and innovation portfolio of EUt+ as a whole, with focus on distinctive capacities, internal and external collaborations, and the alignment of research and innovation with societal challenges and territorial priorities. This is complemented by the third product which are the Institutional R&I mapping slide decks. They present key charts and descriptive visualizations of the research and innovation activities of each EUt+ member based on the EUt+ mapping slide deck, with the same data sources and similar analysis. They also benefit greatly from the common EUt+ OpenAire research portal created in task 8.6 by the EUt+ Academic Press Team.

The three tools of the EUt+ R&I mapping are complementary with the further results and insights currently under development in the project. These are tasks 3.2 concerning the mapping demand by SMEs, task 4.2 performing an external analysis on socioeconomic developments and priorities, task 4.3 producing a dashboard for external analysis of research trends and task 5.2 creating a common research infrastructure pool for EUt+.

The results are discussed together with the suggested way of publishing the toolkit on the EUt+ webpage.

TOPIC 4 CLUSTERS DEVELOPMENT

The status of the clusters presently under development for degrees in engineering on bachelor and master level are presented for discussion. The mobility maps developed are shown together with the courses included as a mobility offer to students. The underlying formative principle of automatic recognition of credits received from a partner is explained together with the foreseen level of languages to be taught. One factor in the discussion are the partners' academic calendars and how to make them compatible in order to enable meaningful mobility for the lengths of a full semester.

Such committees comprise the vice presidents of a given sector, e.g. for research or education, respectively, and the rationale is the interlinking of joint activities in the sector between the EUt+ partners for the purpose of coordination and steering. The committees are embedded into the existing structures of partner universities and work on the trajectory towards convergence of the piloting of their structures and subsequent crossed representations in the EUt+ bodies, and progressively, the entanglement of piloting, management and subsequent decisions.

In addition, the General Secretary presents on the profile needed for providing a representative from each EUt+ alliance member to the Secretariat General and the fitting person profile.

TOPIC 6 EUROPEAN CALLS

The calls for proposals on European policy experimentation in higher education with the topics for a pilot a joint European degree label and a pilot to explore the feasibility for a possible European legal status for alliances of higher education institutions is expected. 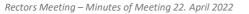
